BITCH OWNER AGREES TO:

1. Pay agreed non refundable fee before bitch is serviced of \$500 and pay the rest due once the litter is two weeks old *or before*. (RCR will not sign AKC/UKC registration papers before amount is paid in full.)
2. Provide picture & three (3) generation pedigree of bitch to stud owner before servicing.
3. Agrees to use full shipment of semen received in one insemination.
4. Agree to provide stud dog owner statement from a licensed veterinarian* no later then 70 days after mating if no pregnancy results from mating. Failure to do so will result in no return service. (* Unless using RCR's breeding specialist, Dean Bitzel of NeverGone Canine Breeding LLC, located in Wabash, IN.)
5. Keep bitch properly confined following breeding to ensure no other dog could mate her accidentally before mating season is finished.
6. Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any person or firm connected with the business of resale or wholesale of dogs.
7. Notify stud owner of heat in a timely manner.
8. Agree to provide stud owner with date of birth, number of puppies & picture of litter within one (1) week of birth.

STUD OWNER AGREES TO:

1. Provide bitch owner with a 3 generation pedigree of stud dog.
2. Have stud dog in good physical condition, current with annual vaccinations and a clear Brucellosis test done within one (1) year of semen collection.
3. Sign litter registration promptly and return to bitch owner, after bitch owner has paid the stud fee in full.
4. Provide a return service to same bitch within a year if no pregnancy resulted from mating, without having to repay the \$200 deposit.

STUD SERVICE FEES COVER:

A. One (1) trip to Artificial Insemination (AI) site if done with in 50 miles of our home. Any additional trips will be \$100. Progesterone testing of your dam is encouraged before you set up the AI appointment.

or

B. Fresh, or fresh chilled quality semen shipped to your vet with the agreement that all vet fees are the bitch owner's responsibility. Bitch owner will need to call our provider with credit card information before collection of semen will take place.

OTHER CONDITIONS:

1. To receive return service bitch owner must provide stud dog owner a verification statement from a licensed veterinarian that full shipment of semen was used in each AI and bitch failed to conceive not more than 70 days following mating. If stud is no longer available for whatever reason for return service, stud owner reserves the right to terminate this agreement with a refund of fifty percent (50%) of the stud fee.
2. Three (3) live puppies at age of one week (1) constitutes a litter.
3. This agreement is terminated if bitch fails to conceive on return service.
